Primary Purpose: Plans, coordinates, and implements various Help Desk activities and functions by performing the following duties.

Essential Duties and Responsibilities

1. Set up computers.
2. Prepares system build checklists and delivery reports for all computers.
3. Participates in the Help Desk call center. Troubleshoots software, hardware, and printer related issues.
4. Uses the Help Desk ticketing software, Invgate, to document all support issues and log all calls.
5. Installs hardware and software on computers as needed.
6. Helps maintain up to date information in Active Directory.
7. Helps with computer operations, including but not limited to, running mainframe jobs and printing.
8. Coordinate with other departments regarding special computer projects, new equipment replacements, etc.
9. Adds Knowledgebase articles in Invgate.
10. Participates in weekly after hours/on call rotation.
11. Support company events during and after normal business hours.

Additional Duties and Responsibilities

1. Performs other duties as assigned.
2. Supports the organization's quality program(s).

WORK ENVIRONMENT

The employee will work in an office environment. The noise level in the work environment varies from quiet to moderate.

Mental: Clear and conceptual thinking ability; excellent judgment, troubleshooting, problem solving, analysis, and discretion; ability to handle work-related stress; ability to handle multiple priorities simultaneously; and ability to meet deadlines

Physical: While performing the duties of this job, the employee is regularly required to sit and use hands to finger, handle, or feel, such as keyboarding and writing. The employee frequently is required to reach with hands and arms and talk and hear. The employee is frequently required to stand and walk. Must have visual acuity to read and draft reports, memos, letters, etc. Specific vision abilities required by this job include vision adequate for the incumbent to perform the responsibilities and functions of the job efficiently.
